Cleary Senior Counsel Ed Greene was among the small group of attorneys who created the Council of New York Law Associates, the predecessor to Lawyers Alliance, in 1969. For Cleary, commitment to pro bono has been a core value of the firm since its inception, and in recent years

it has emphasized leadership in nonprofit law, offering holistic legal advice to probono nonprofit clients and drawing knowledge from across the firm.

The firm has partnered with Lawyers Alliance on 59 different pro bono matters for 52 organizations since July 1, 2017, as well as dozens of projects involving attorney externs. Cleary has positively impacted the criminal justice system in New York City, helping to launch and advise the **Brooklyn Community Bail Fund, now known as Envision Freedom Fund,** which has evolved into a key force in the immigration bond fund space. The firm is currently drafting a template fiscal sponsorship agreement for **Good Call,** a nonprofit founded to make the arrest process and its aftermath less painful for detained individuals and their loved ones. Thanks to Cleary volunteers, nonprofits are better able to navigate legal issues that are critical to their programs.

Cleary was the first firm to sponsor an extern at Lawyers Alliance. From 1989 through this year, 89 Cleary associates have worked full time at Lawyers Alliance for four to six month rotations. This has enabled Lawyers Alliance to expand its work, deepened the nonprofit law knowledge at Cleary, and reinforced a public service spirit among firm attorneys and alumni.

Q. How does the firm encourage and support business and transactional lawyers at all levels to participate in pro bono?
